- ?? All merchandise is subject to approval and items not previously approved are not allowed.
- ?? Payment must accompany this application. **THERE ARE NO REFUNDS ON APPROVED APPLICATIONS.**
- ?? Use of the Seafair logo is strictly prohibited.
- ?? T-shirts with silk-screened or heat pressed logos will not be allowed for display or offered for sale.
- ?? Applications are juried in order received. Booth location will be at the discretion of the Committee taking into consideration your requests.
- ?? Artists must provide their own tables, chairs, display equipment, etc.
- ?? Artists are limited to 3.3 amps or 400 watts electrical power from one outlet and must provide their own extension cords and power strips.
- ?? Please keep your walkways clear. Do not alter the booth space. Booth must be left clear of trash after breakdown.
- ?? No vending from trailers
